### SECTION 4 – FIRST AID MEASURES

### SECTION 7 – HANDLING AND STORAGE

<b>Handling</b>	Avoid eye contact with concentrate. Wear protective clothing when risk of exposure occurs. Avoid contact with incompatible materials. When handling, DO NOT eat, drink or smoke. Keep containers closed at all times. Avoid physical damage to containers. Wash hands with water after handling.
<b>Storage</b>	Store in a cool, dry, well-ventilated area, out of direct sunlight. Protect from freezing. Store in suitable, labelled containers. Keep containers tightly closed. Store away from incompatible materials. Ensure that storage conditions comply with applicable local and national regulations.
